## Traditional Bachelor of Science in Nursing (TBSN) | 2023-2024 SUPPLEMENTAL IMPACTION CRITERIA

The CSUSM Traditional Bachelor of Science in Nursing (TBSN) program is a direct-entry admission major. Students may only enter the major at the time of admission to the university. There are two levels of supplemental impaction criteria:

1. First-Time Freshman Supplemental Impaction Criteria
2. Transfer Supplemental Impaction Criteria

Students admitted to CSUSM in a different major or students currently enrolled are not able to apply or change majors to the TBSN. CSUSM no longer has a Pre-Health Sciences pre-major.

## 1. First-Time Freshman Supplemental Impaction Criteria

First-time Freshman applicants to CSUSM are rank ordered according to the following criteria:
a. Multiple Measures as determined by the CSUSM Office of Admissions (https://www.csusm.edu/admissions/how-toapply/freshman/index.html)

## 2. Transfer Supplemental Impaction Criteria

Transfer applicants to CSUSM are rank ordered according to seven criteria. Each criteria carries a point value for a total of up to 68 points. Applicants must meet the minimum prerequisite course requirements and GPA to be eligible for admission to TBSN rogram.

a. Criteria 1: Pre-Nursing Core (Prerequisite Courses) GPA Maximum Points: 25

Grade point average (GPA) in Pre-Nursing Core (Prerequisite) courses or equivalents (except in-progress courses)
i. Methodology:

1. The cumulative grade point average (GPA) is computed for the eight Pre-Nursing Core courses (or their equivalents) using a 4.0 grading system.
2. A grade of C or better is required in each course (a C- is not acceptable in any separate course, including labs).
3. Only two science courses may be completed with a grade of B- or less.
4. An overall minimum GPA of 2.75 .
5. Courses must be completed on an A-F grading basis.
6. Courses in progress are not calculated in the Pre-Nursing Core GPA.

i. Notes:

1. Courses with substandard grades (C- or below) can be repeated only once and grades earned will be averaged.
2. Initial grade of $C$ or better cannot be repeated and will not be accepted.
3. Course equivalents from Community Colleges are determined using http://www.assist.org. When there is no articulated course the School of Nursing determines course equivalence for admission to the major.
4. An Integrated Chemistry course is recommended. Please note: An Introduction to Chemistry course does not meet the requirement.
5. Course credit earned through AP or IB exams taken in high school meeting the CSUSM requirements will be accepted and will not be calculated into the Pre-Nursing Core GPA.
6. Pre-Nursing Core courses must be completed no later than the end of the Spring semester prior to enrollment.
7. Courses In Progress during the Spring semester prior to enrollment are not calculated into the Pre-Nursing Core GPA.

c. Criteria 3: Test of Essential Academic Skills (TEAS) Composite Score

Maximum Points: 12
All Transfer applicants are required to take the TEAS exam Version 7 produced by Assessment Technologies, Inc. (ATI) and earn a minimum score of $71.0 \%$. No other assessment will be accepted in lieu of the TEAS exam. The TEAS may be repeated a total of three (3) times and the highest score will be used for application to the TBSN program.

The exam includes four subtests:

1. MATH: whole numbers, metric conversions, fractions and decimals, algebraic equations, percentages, and ratio/proportion
2. READING: paragraph comprehension, passage comprehension, and inferences/conclusions
3. ENGLISH: punctuation, grammar, sentence structure, contextual words, and spelling
4. SCIENCE: science reasoning, biology, chemistry, anatomy and physiology, basic physical principles, and general science

e. OPTIONAL Criteria 5: Work and/or Volunteer Experience

Maximum Points: 5

Applicants may demonstrate work and/or volunteer experience by providing a letter (for each employer or volunteer organization) on organization letterhead detailing the type of work, hours completed, whether the work was on a part- or full-time basis, and whether the hours were completed as an employee or volunteer. If organization letter does not indicate part- or full-time status part-time will be considered anything less than 32 hours per week and full-time will be considered anything over 32 hours per week.

Work at a private residence must be in one of the work categories below, employed with a health care agency, and trained and supervised by a physician or registered nurse.

Residency is based on the institution where the last 60 CSU-eligible units were completed. In the event the last 60 units were completed at more than one institution residency will be based on the institution where most of the units were completed.
