FEATURED FUNDING OPPORTUNITIES

Program: 2024 Fulbright-Hays Group Projects Abroad program
Sponsor: US Department of Education & Fulbright Foundation

Synopsis: The purpose of the Fulbright-Hays GPA Program is to promote, improve, and develop the study of modern foreign languages and area studies in the United States. The program provides opportunities for faculty, teachers, and undergraduate and graduate students to conduct group projects overseas. Projects may include either (1) short-term seminars, curriculum development, or group research or study, or (2) long-term advanced intensive language programs.

Deadline: March 18, 2024

Program: Research Grants in the Arts

Sponsor: National Endowment for the Arts (NEA)

Synopsis: The program supports research studies that investigate the value and/or impact of the arts, either

as individual components of the U.S. arts ecosystem or as they interact with each other and/or with other

domains of American life. **Deadline:** March 25, 2024

Program: USDA-NIFA Higher Education Multicultural Scholars Program (MSP)

Sponsor: National Institute of Food and Agriculture

Synopsis: The purpose of the Higher Education Multicultural Scholars Program (MSP) is to provide scholarships to support recruiting, engaging, retaining, mentoring, and training committed multicultural scholars, resulting in either baccalaureate degrees within the food and agricultural science disciplines. The goals and objectives of the scholarships are to encourage outstanding students from groups that are historically underrepresented and underserved to pursue and complete baccalaureate degrees in food and agricultural sciences, that would lead to a diverse and highly skilled work force. This may include the teaching and preservation of traditional ecological knowledge.

Deadline: April 1, 2024

Program: <u>NEH Awards for Faculty at Hispanic-Serving Institutions program</u>

Sponsor: National Endowment for the Humanities

Synopsis: The Awards for Faculty program strengthens the humanities at Hispanic-Serving Institutions by encouraging and expanding humanities research opportunities for individual faculty and staff members. Awards support individuals pursuing scholarly research that is of value to humanities scholars, students, and/or general audiences. The program welcomes proposals in all areas of the humanities, regardless of geographic or chronological focus. This program offers applicants flexibility in project outcomes and award periods. Projects must be based on humanities research.

Deadline: April 10, 2024

Program: SuRE

Sponsor: National Institutes of Health

Synopsis: SuRE is a research capacity building program designed to develop and sustain research excellence in U.S. higher education institutions that receive limited NIH research support and serve students from groups underrepresented in biomedical research NOT-OD-20-031 with an emphasis on providing students with research opportunities and enriching the research environment at the applicant institutions.

1. Support for Research Excellence (SuRE) Award (R16 Clinical Trial Not Allowed)

Budget: Applications may request up to \$100,000 direct costs/year.

Expected deadline: between end of April and beginning of May 2024

Synopsis: The purpose of SuRE awards is to provide research grant support for faculty investigators who have prior experience in leading externally funded, independent research but are not currently funded by any NIH Research Project Grants with the exception of SuRE or SuRE-First awards. SuRE-supported projects must have student participation in the execution, analysis, and reporting of the research. An applicant institution must demonstrate a commitment to build its research capacity and support the Principal Investigator for the award.

 Support for Research Excellence – First Independent Research (SuRE-First) Award (R16 -Clinical Trial Not Allowed)

Budget: Applications may request up to \$125,000 direct costs/year.

Expected deadline: September 2024

Synopsis: The purpose of SuRE-First awards is to support research grants for faculty investigators who have not had prior independent external research grants. SuRE-First-supported projects must have student participation in the execution, analysis, and reporting of the research. An applicant institution must demonstrate a commitment to build its research capacity and support the Program Director/Principal Investigator of the award.

Program: Hispanic-Serving Institutions: Enriching Learning, Programs, and Student Experiences

Sponsor: National Science Foundation

Synopsis: The HSI:ELPSE solicitation supports projects that are purposefully designed to meet students where they are, accounting for both their assets and the challenges they may face. Identities and experiences are not determined solely by membership in a single monolithic population of students (e.g., Hispanic, first-generation, commuter, etc.). Consequently, institutions are expected to use institutional data to identify equity gaps, identify areas of need, and unpack the factors that shape students' individual realities and shared experiences. Perspectives gained from these data should be central to the design of the project.

Deadline: June 4, 2024

Program: <u>Developmental Sciences</u> Sponsor: National Science Foundation

Synopsis: Developmental Sciences supports basic research that increases our understanding of perceptual, cognitive, linguistic, social, cultural, and biological processes related to human development across the lifespan. Research supported by this program will add to our knowledge of the underlying developmental processes that support social, cognitive, and behavioral functioning, thereby illuminating ways for individuals to live productive lives as members of society.

Deadline: July 30, 2024

CSUSM Wins National Prize for DEIA Excellence in Research Spaces



Cal State San Marcos is one of 10 universities nationwide to receive a \$100,000 prize from the National Institutes of Health for demonstrating exceptional dedication and innovation in fostering diversity, equity, inclusion and accessibility within research environments.

CSUSM was <u>announced recently as among 10 recipients</u> of the NIH Institutional Excellence in Diversity, Equity, Inclusion, and Accessibility (DEIA) in Biomedical and Behavioral Research Prize. The award is given by the NIH Chief Officer for Scientific Workforce Diversity (COSWD) team.

Of the 10 winners, CSUSM is one of only three that are considered limited-resource institutions (LRIs). NIH defines LRIs, among other criteria, as "institutions that have a documented mission to serve historically underrepresented populations in biomedical and behavioral research."

CSUSM received the NIH prize specifically for the work of the Center for Research, Training and Educational

<u>Excellence</u> (CTREE), the mission of which is to enhance the educational and research experiences of students from underserved backgrounds in higher education. CTREE is led by director Denise Garcia, a biology professor, and associate director Richard Armenta, a kinesiology professor.

"The establishment and operation of CTREE represent a university-wide achievement," Garcia said. "Our success is attributed to exceptional administrators who recognized and supported our vision, dedicated staff tirelessly managing our programs and grants, and amazing faculty members who generously invest their time as research mentors for our students. Above all, our achievements are fueled by the remarkable efforts of our incredible students, who wholeheartedly strive to turn their dreams into reality."
