ELECTRONIC WORKING PERSONNEL ACTION FILE (e-WPAF)

Instructional Faculty

The School of Education Office, highly recommends all Lecturers (those teaching courses and Supervising Teacher Candidates) required to submit a Working Personnel Action File according to the terms of their contract, prepare an Electronic Working Personnel Action File (e-WPAF).

How to Log-in to Your e-WPAF Moodle Container

The e-WPAF container is created automatically in the CSUSM Community Moodle site. If you do not see the container with the current AY in the title, email [Barbara Taylor](mailto:Barbara.Taylor@csusm.edu) and/or [Susan Eldridge](mailto:Susan.Eldridge@csusm.edu) (Academic Technology – Instructional Development Services) to request the container. Please also copy Melinda Jones your department Academic Support on the request.

The Lecturer shall have access to their WPAF at all reasonable times except when the WPAF is undergoing review.

1. Go to CSUSM Community Moodle site: <http://community.csusm.edu>
2. Log-in with your CSUSM credential and password
3. Under "MY COURSES" you should have a container labeled as:
"Your Last Name, Your First Name AY xx/xx"
4. Click on your container to open
5. Review the container contents and read through the following:
 - a. FAQ
 - b. WPAF process
 - c. Narrative Tips
 - d. Narrative Notes

How to Edit in Your e-WPAF Moodle Container

1. **Turn Editing On:**
 - a. click on green button, upper right corner
2. **To Download Document:**
 - a. Click on "Document Title"
 - b. Document will open
 - c. In your browser window click, "Download Icon" (typically a down arrow in a toolbar above the document)
 - d. Save document to your computer (Suggestion: create a folder on your computer to contain all documents for your WPAF)
 - e. To return to the main page of your e-WPAF, in your browser window click on the "back arrow".
3. **To Upload Document:**
 - a. Click on the, "+ Add an activity or resource" link
 - b. A window will open, scroll down, under "RESOURCES", select "File"
 - c. Click, "Add"
 - d. In the "Name" box, type the title you wish to label the document.
 - e. From your computer you may drag and drop your document into the "Content", "Select File" box.
 - f. To finish, click "Save and return to course"

Note: You do not need to fill in the description box, or complete any other options available.

4. **To Delete Document:**
 - a. Click the "Edit" link to the right of the document title
 - b. A drop down menu will open and select "Delete"
5. **Turn Editing Off:**
 - a. click on red button, upper right corner

Document Instructions

PDF documents are preferred, Word documents are acceptable.

1. **Completed Checklist**
 - a. Download this PDF document
 - b. Either type or handwrite to mark (X) or initial the items in the checklist that you will be including in your WPAF
 - c. Sign the document, then scan and upload
 - d. You may then delete the original blank document

Note: If you believe that you are not required to submit a requested item, label Not Applicable (N/A). (e.g.: "Copies of all prior periodic evaluations with responses/rebuttals (if any)"). If this is your first evaluation, you obviously will not have prior evaluations to include. So mark this box as, N/A.)
2. **Index of Material**
 - a. Download the Word document
 - b. This document will be a personalized index of items that you are including in your WPAF.
 - c. Upload document
 - d. Delete the original blank document
3. **Current Curriculum Vitae**
 - a. Upload a current copy of your curriculum vitae / resume
4. **List of Courses Taught in the Department**
 - a. Prepare a document with a list of the course(s) you are teaching during the timespan of this evaluation period.
 - b. Upload document
5. **One Representative Syllabus**
 - a. Upload the syllabus you prepared, for each of the courses you listed in Section #4
6. **The Complete University-Prepared Report of the Student Evaluations of Instruction**
 - a. Each semester the University requires all course instructors to have their students/teacher candidates complete an evaluation of their course instructor. The University provides the prepared evaluation forms for distribution along with instructions on how to conduct the evaluation. A notification from the University is sent to instructors of when the forms are available to pick up from your campus mailbox. If you have not received this notification prior to the end of your class please contact Donna Matanane, matanane@csusm.edu, Assistant to the CEHHS, Associate Dean.
When the student evaluations are complete, the University prepares an analyzed report and e-mails a copy of the report to the course instructor.
 - b. Upload the University-Prepared Report

Note: There is a possibility that the University-Prepared Report may not be available by the due date of your WPAF. If this is the case, please upload a document stating that the Report was not available to you by the due date. Also, note this in your Checklist and Index of Materials.

7. **Course Materials**
 - a. Upload applicable documents, pertaining to this evaluation cycle:
 - i. Sample lesson plans
 - ii. Assessments of student learning outcomes
 - iii. Assignments
 - iv. Examples of student work
8. **Materials required in accordance with approved college/division and/or department/program or equivalent criteria**
 - a. Form B – Content Area Faculty/Program Coordinator Input
 - b. Form C – Classroom Observation of Instructor
 - c. Form D – Content Area Clinical Practice Coordinator and/or Program Coordinator Input (if applicable)
9. **Copies of all prior periodic evaluations with responses/rebuttals (if any)**
 - a. If you have been evaluated in the past, please upload all copies of previous evaluations from the Dean and/or Director.
 - b. If this is your first WPAF submission, please upload a document noting, “No prior evaluations.”
10. **A Copy of The Relevant University Procedure, and All College/Division, and Department/Program Lecturer Evaluation Criteria**
 - a. The document required for this section, should have been included for you. It is titled, “University Evaluation Procedures”. You do not need to upload any other documents. If this document is not included, please download this document and upload to your WPAF:

11. **Optional: Any other evidence relevant to the duties of the appointment**
12. **Optional: Evidence of scholarship, professional development, creative activities, and/or service to the campus, the community and/or the profession, whether or not these are required by the appointment.**
13. **Optional: Peer input from the period being evaluated.**
14. **A self-assessment or reflection with respect to the duties of the appointment for the evaluation cycle**
